Description: This activity will provide a comprehensive review of EKG interpretation across a variety of clinical scenarios. Participants will explore normal cardiac conduction and the diagnostic approach to EKG analysis, along with how to identify and manage abnormalities associated with conditions like chest pain, syncope, pulmonary embolism, pericarditis, congenital heart disease, and sudden cardiac death (SCD). The course also covers the impact of medical treatments on EKG findings, helping learners understand the nuances of interpreting EKGs in these common yet challenging cases.

Audience: This course is designed for hospitalists, nurse practitioners, physician assistants, advance practice nurses, registered nurses, allied health professionals, physicians and residents.

At the end of this session, learners will be able to:

- l. Review normal cardiac conduction and intervals, and apply a systematic approach to EKG interpretation.
- 2. Analyze EKG findings in clinical scenarios such as chest pain, syncope, pulmonary embolism, pericarditis, congenital heart disease, and sudden cardiac death.
- 3. Understand how medical treatments influence EKG patterns and apply this knowledge to optimize patient care.
