Description: Gastroesophageal reflux disease (GERD) is a prevalent and multifactorial condition that often requires a nuanced approach to management. This activity will provide participants with an in-depth understanding of the pathophysiologic and anatomic derangements associated with GERD, enabling a clearer perspective on the disease's progression. Emphasis will be placed on redefining the role of antireflux surgery within the current GERD management algorithm. Additionally, attendees will critically review the risks, benefits, and indications for pharmacologic, endoscopic, and surgical treatments, helping clinicians optimize care for patients with GERD. By integrating updated clinical evidence, this activity aims to improve therapeutic decision-making and patient outcomes in GERD management.

Audience: This course is designed for hospitalists, nurse practitioners, physician assistants, advance practice nurses, registered nurses, allied health professionals, physicians and residents.

1. Understand the pathophysiologic and anatomic derangements in GERD.

3. Review risks and benefits of pharmacologic, endoscopic, and surgical treatments.
